NOTIFICATION

In exercise of the powers conferred by the proviso to article 309 of the Constitution of India, read with the Notification No.F.5/4/65-GP, dated 11th January, 1965 of the Ministry of Home Affairs, Government of India, New Delhi and in supersession of the Notification issued in G.O. Ms. No: 53, dated 28.05.1982 of the Home Department, published in Supplement to the Gazette No. 23 of 08th June, 1982 and save as respects things done or omitted to be done before such supersession, the Lieutenant Governor, Puducherry hereby makes the following rules regulating the method of recruitment to the post of Junior Reporter in the Home Department, Government of Puducherry, namely:-

1. Short title and commencement. -

- (1) These rules may be called the Government of Puducherry, Home Department (Junior Reporter - Group 'C') Recruitment Rules, 2017.
- (2) They shall come into force on and from the date of their publication in the official gazette.

2. Number of posts, its classification and level in the Pay Matrix. -

The number of the said posts, its classification and the scale of pay attached thereto, shall be as specified in columns (2) to (4) of the Schedule annexed hereto.

3. Method of recruitment, age-limit and other qualifications.-

The method of recruitment to the said post, age-limit, qualifications and other matters relating thereto, shall be as specified in columns (5) to (13) of the said Schedule.

4. Disqualifications. - No person.-

- (a) who has entered into or contracted a marriage with a person having a spouse living; or
- (b) who, having a spouse living, has entered into or contracted a marriage with any person,

shall be eligible for appointment to the said post:

Provided that the Lieutenant-Governor may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and there are other grounds for so doing, exempt any person from the operation of this rule.

5. Power to relax. - Where the Lieutenant-Governor is of the opinion that it is necessary or expedient so to do, he may, by order and for reasons to be recorded in writing, relax any of the provisions of these rules with respect to any class or category of persons.

6. Saving. - Nothing in these rules shall affect - the reservations, relaxation of upper age limit and other concessions required to be provided for the Scheduled Castes, the Scheduled Tribes, Ex-Servicemen and other special categories of persons, in accordance with the orders issued by the Government from time to time in this regard.

3.	Classification	General Central Service Group 'C' - Non-Gazetted-Non-Ministerial.

6.	Age limit for direct recruits	Between 18 and 30 years (Relaxation of age will be as per order in force) Note 1: In the case of recruitment made through advertisement, the crucial date of determining the age limit shall be the closing date of receipt of applications. Note 2: In the case of recruitment made through Employment Exchange, the crucial date for determining the age limit shall, in each case, be the last date upto which the Employment Exchanges are asked to submit the names.
7.	Educational and other qualifications required for direct recruits.	Essential: 1. Must have passed H.Sc (+2) or its equivalent with Tamil as Second Language, 2. Higher Grade Technical Examination in Shorthand and Typewriting of the Government of Tamilnadu in Tamil. Desirable: A Degree of a recognised University with Tamil as second Language (10+2+3).
8.	Whether age and educational qualifications prescribed for direct recruits will apply in the case of promotees.	Not applicable
9.	Period of probation, if any	Two years
10.	Method of recruitment, whether by direct recruitment or by promotion or by deputation/absorption and percentage of the vacancies to be filled by various methods.	By direct recruitment Note: Vacancies caused by the incumbents being away on deputation or long illness or study leave or under other circumstances for a duration of one year or more may be filled on deputation basis from Officials of Puducherry Administration - A) (i) Holding analogous posts on regular basis; or (ii) With 5 years regular service in posts in Pay Band - 1: Rs. 5200 - 20200 with Grade Pay Rs. 1900; and B) Possessing the qualifications prescribed for direct recruits under column (7)-
