As you are kindly aware, Rule 15(2) of the Arms Rules, 2016 notified on 15.07.2016 provides that "with effect from the 1<sup>st</sup> day of April, 2017, any arms licence without UIN shall be considered invalid. Accordingly, the State Governments/UT Administrations were requested to complete the uploading of data of arms licence in NDAL by 31.03.2017. The portal of NDAL was closed by the NIC after 31<sup>st</sup> March, 2017.

2. However, the Ministry has received a number of representations from various State Governments/Union Territories Administration and individuals requesting for extension of last date of uploading of data in NDAL portal on the ground that then UINs have not been generated by the DM/ State Government concerned.

3. Keeping in view that there is still a big gap between the number of active licences and the number of UIN created, the Competent Authority in MHA has approved extension of last date for uploading of data in NDAL till 31.03.2018. A notification in this regard has been published in the Gazette of India vide GSR No. 1468 (E) dated 28.11.2017 (Copy attached).

4. I therefore, request you to kindly instruct the official concerned to complete the uploading of data related to arms licence in the NDAL portal within the stipulated date and this may be given top most priority. Further, a fortnightly report for uploading of data in NDAL may also be sent on the email IDs. 5. Further, vide this Ministry's letters of even number dated 10.11.2017 and 23.11.2017, the State Governments/UT Administrations were requested to provide the updated status regarding the licences whose UIN have not been generated and the reason why the UIN were not created regarding all active licences. This is still awaited. Therefore, it is once again requested that data upto 30.11.2017 may be provided in the following format.
